

The following rules are in accordance with DAFI 34-101, AFMAN 48-114, and local operating instructions established to provide a safe swimming environment for all patrons.

1. Pool Patrons must show Base ID card and may have one guest per Base ID card holder. Guests are authorized on a space available basis only.
2. Pool Operation Hours: Monday through Sunday 1000-1900
Max Capacity: 100 People
3. In case of emergency, dial 911. Nearest phone is located at the pool check-in desk.
4. Children 10 or younger shall be under the direct supervision of an Adult and wear a properly sized and fitted United States Coast Guard approved personal flotation device (pool does not provide flotation device).
5. Children 11 - 15 shall pass a swim test that is conducted by on duty Lifeguard and be supervised by an adult. If the child does not pass the swim test, they must comply with number 4 above.
6. Patrons 16 years of age and over with a Base ID card in their possession may use the facility unattended without passing a swim test.
7. Children not toilet trained shall wear swim diapers.
8. No diving allowed.
9. No breath-holding or prolonged underwater swimming contests.
10. Food, beverages, chewing gum, smoking, chewing tobacco and snuff prohibited in pool and on pool apron.
11. Alcohol is not allowed in the pool area. Individuals who are intoxicated, have an odor of alcohol, or are suspected to be under the influence will not be allowed to enter the pool.
12. Glass containers prohibited in pool area. Please dispose of your waste properly in the trash cans provided.
13. Individuals experiencing the following conditions shall be prohibited from entering the pool: diarrhea, skin disease, open sores, or lesions, including live immunizations, sore or inflamed eyes, nasal or ear discharge.
14. No pets are allowed in the pool area. (Service dogs escorting persons with disabilities shall be permitted on the pool apron and in restrooms. Also, working dogs accompanied by handlers shall be permitted in swimming pool areas as required.)

15. Showers are required before entering pool.
16. Lifeguards will clear the pool area during electrical storms and at other times deemed necessary in the interest of safety.
17. Personal flotation devices must be United States Coast Guard approved. Patrons using approved flotation devices must be directly supervised and stay in shallow water. Inflatable water wings are an example of a non-approved device. Mermaid fins and items which bind the feet are never authorized due to safety concerns.
18. During recreational swim, a rope or cable with floats or buoys shall divide the deep end and the shallow parts of the pool, in the open area of the pool.
19. Each qualified lifeguard conducting patron surveillance shall have a rescue tube on his/her person.
20. No running, pushing, or horseplay of any kind. Lifeguards will deem what is unsafe.
21. Appropriate attire must be worn in all aquatic venues. Nude bathing areas are not allowed.
